



#### **Age Increase for Child Funeral Charity Applications**

The Child Funeral Charity is pleased to advise you that the Charity Commission for England and Wales has agreed that, with immediate effect, we can offer support to families whose child died under the age of 18. This means that we are now able to support families with funerals for babies and children from 12 weeks' gestation up to and including 17-year-olds.

Our aim is to enable families in financial hardship to provide a simple, dignified funeral, and basic commemorative items, for their child or baby. Referrals can be sent in by funeral directors and arrangers and other professionals working with bereaved parents. We will continue to decide each case on its merits, bearing in mind the age of the child and there are updated requirements for successful applications which are on the charity's website, www.childfuneralcharity.org.uk

In terms of timing of referrals, the funeral has to have either not yet taken place, or took place less than four weeks before the date of the application for help. For memorial items, such as plaques or memory bears, the application must be made within one year of the date of the

funeral.

## Heart of England is first UK Co-op to help unite families with loved ones' lost ashes

Coventry's independent Heart of England Co-operative Society is helping to reunite families with the uncollected ashes of loved ones dating back as far as the 1950s.

The Society says it is the first UK co-operative to join a ground-breaking online initiative to address what is a long-standing issue in the funeral sector.

Details of 725 unclaimed remains have been uploaded to The Ashes Register. The urns containing the ashes are being stored at 16 funeral homes in the Co-op's trading area covering Coventry, Warwickshire, and parts of Northamptonshire and South Leicestershire.

The oldest remains are of Alexander Anderson who was cremated at Canley Crematorium, Coventry in 1956. It is estimated that hundreds of thousands of unclaimed urns are sitting in funeral homes across the nation.

Matthew George, head of client services at Heart of England Co-op Funerals, explained that there are many reasons why relatives fail to pick up ashes.

"Sometimes people who have suffered a loss find it very hard to come and collect the ashes as it brings a sense of finality. However, at times it can simply be down to a miscommunication between family members as to who is collecting the cremated remains.

"Sadly, another reason is that the deceased has no known next of kin. Some people also leave the ashes until they pass away themselves so that they can be scattered or buried with their loved ones."

He welcomed the new database, adding that the Society is proud to be leading the way in the co-operative world.

The National Association of Funeral Directors advises that cremated remains should be retained for at least five years. However, the Heart of England Co-op has been holding onto its unclaimed urns for decades.

"We keep them until they are collected by the family," said Mr George. "We have been serving our community for 192 years and we feel a strong duty of care to look after the cremated remains of people whose funerals we arranged. We believe that they need to be afforded the same level of professional care and respect as when they were first brought into our care.

"Details of all the cremated remains in our possession are also diligently recorded and logged within our own databases. The urns are kept in secure locations in each of our funeral branches. Each set of ashes is stored alongside the relevant cremation certification to ensure easy identification."

Whilst most cremated remains are kept at the branch where the funeral was organised, the oldest ones are kept in a special storage area at the Co-op's funeral home in Towcester.

The Ashes Register was set up by Richard Martin to enable the public to register a set of ashes and to create a permanent record of where they were scattered. The unclaimed ashes section of the website is a recent addition.

He said "We initially set up this website to provide a space for people to document a person's final resting place. We are now also aiming to reunite as many people as possible with the uncollected ashes of a relative or loved one. We feel so passionate about history not being lost in time.

"We have received lots of support from leading companies and organisations in the cremation sector on the Ashes Register. The Heart of England is the first co-operative in the whole of the UK to step forward and become involved in the new unclaimed ashes section of the website."

#### Medical examiners update from the MoJ

Dear all,

Thank you for all your work to implement the Death Certification Reforms on 9 September 2024. In the 5 months since that date, there have been around 224,000 deaths registered and based on 2023 trends we estimate that there have been around 183,000 cremations since 9 September 2024. We are extremely grateful for your ongoing support in helping to embed these important changes that better protect the public.

#### Hazardous medical device information

As expected with changes of this magnitude, there have been some teething issues, in particular around the flow of information relating to hazardous medical devices. We have heard, in particular, some concerns about the frequency with which 'don't know' is ticked on form Cremation 6.

The need for information about hazardous medical devices to be passed through the system pre-dates the Death Certification Reforms: prior to 9 September 2024, in coronial cases the coroner would only notify the crematorium about medical devices present in the deceased person if they had this information as a result of examining medical notes or completing a post-mortem examination. This information would usually have been included as part of the e-mail sent alongside the form Cremation 6. If the coroner did not know whether a device was present, they would simply provide the form Cremation 6 and no further information. Post 9 September 2024, where information relating to hazardous medical devices is available, we expect the

coroner to provide that information on form Cremation 6; this includes whether the device has been removed or not. We therefore expect the same procedures to be used when the coroner indicates they don't know as was the case prior to the 9 September 2024 when this information was not provided. This might include the MR making enquiries with the coroner's office.

If the presence of hazardous medical devices is not known and the coroner's office has confirmed they do not have the information (and the coroners have provided this information on form Cremation 6) then you may find it useful to get in touch with the referring attending practitioner (AP), or the pathologist (if known). In relation to non-coronial cases, it is the responsibility of the AP to complete the MCCD and to provide information relating to hazardous medical devices from deceased patient's medical notes. Guidance is provided to the AP on how to complete the MCCD, which includes a list of potentially hazardous implantable medical devices. You can find this guidance at this link:

https://www.gov.uk/government/publications/medical-certificate-of-cause-of-death-mccd-guidancefor-medical-practitioners/guidance-for-medical-practitioners-completing-medical-certificates-of-causeof-death-in-england-and-wales. MRs should therefore direct questions and concerns related to the

presence of hazardous medical devices to the AP, copying in their local ME for information. In the very small minority of cases where there is no AP and the case has been passed from the coroner to the ME because the death was natural, an ME MCCD will be issued. In such a case, where information about hazardous implants is available in patient records available to the ME, the ME will add that information to the MCCD, so it flows through to the registrar.

We recognise there continue to be issues in ensuring that crematoria have accurate and complete information on the presence of hazardous medical devices and we want to take this opportunity to reassure you all that we are taking these concerns very seriously, and we continue to work with officials across government as well as key stakeholders to ensure we reach a more satisfactory position as quickly as possible.

#### Steps we have taken so far include:

Working with the Department and Health and Social Care to ensure that APs understand that it is their responsibility to complete the MCCD, including providing information on hazardous medical implants, and the impact of failing to pass on this relevant information has on crematoria.

Working with the Chief Coroner's Office on this same issue – we have asked coroners when selecting the 'don't know' option for presence of hazardous implant on form Cremation 6 to provide the rationale for that

conclusion so that the recipient of the form can understand the reason, before determining suitable next steps.

#### **Medical referees**

As you will all know, in October 2024 we conducted a survey of crematorium managers and MRs on the future of medical referees. We thank all participants for their input.

We are currently analysing the responses and considering next steps and will engage further with the sector once our policy analysis is complete, but we want to take this opportunity to reiterate that any change to the role of the MR will be subject to consultation with stakeholders and will require the laying of legislation. We are committed to working with the sector to determine a suitable lead-in time to support any change required. We also recognise the importance of allowing the current system to stabilise before any further actions are taken, and will provide an update, including timings for any next steps, in due course.



#### **SCOTTISH REGULATION**

Regulations are now in place for Scotland as from this month.

New Burial and Cremation forms are to be used and a new Code of Practice, set out by the Scottish Government, for all Funeral Directors in Scotland has been written and must be used.

The new Code of Practice has eight sections to it, and each section has their own subsections.

- These sections are;
  - Introduction
- Engagement of the Funeral Director and Transfer of the Deceased
- Care of the Deceased and Premises Used by the Funeral Director
- Planning the Funeral Service According to the Wishes of the Deceased and the

Bereaved

- Delivery of the Funeral
  - Complaints
- Business Continuity and Managing Risks
- Footnotes


